Number of DNACPR orders issued with and without patient consultation/knowledge. Please note: this has been based on whether the patient has been asked and whether the family were asked if the patient lacks capacity. This shows a total of 229/254 were either asked themselves or family were asked if they lacked capacity. These figures are extracted from one source only, however these discussions can be logged in several places within the patient record which would not be picked up in the data analysis. Quarterly audits into these figures show 100% of patients or patient families had been notified of these orders and discussions logged within their records.
