- A2 The Trust has a private patient oversight group which meets on a regular basis. This is designed to have key stakeholders across the Trusts to be in attendance. This meeting feeds in the Trust's divisional board/governance meetings and the Trust's operational board.

- A3 Monthly reporting of activity verses plan and income position
- Q4 How are you delivering your model?
- A4 Private Patient consultant secretaries manage all inpatient and outpatient appointments as well as secretarial duties. Diagnostic departments manage the administration for Private Patients. There is a dedicated Private Patient administrative team who manage the tracking of Private Patients through their pathway and support with billing. A dedicated Private Patient finance team manages all invoices. The Trust's hospital coordinators support with the management of Private Patients during their inpatient stay.


- A7 Website, patient prospectus and marketing with GP practices
