A1 Each issue/s would depend on the patients presentation at the time, and the eligibility for a service under the Care Act, i.e. the patient will have care needs, that will require support on discharge.

For example, the patients identified below were deemed clinically vulnerable as they had health conditions or had had surgery in hospital or mental health issues, and their home environment was not appropriate i.e. environmental issues, homelessness or safeguarding issues.

The Care Act quotes - The adults needs arise from or relate to a physical, mental impairment or illness.
